Minutes of the February 7, 2006 Meeting de Phil (KB3HMK), - Secretary - LVARC

Lehigh Valley Amateur Radio Club (W3OI) Meeting Minutes



President Wolfe called the meeting to order at 1930 hrs, EST. The meeting started with the Pledge of Allegiance, and then a moment of silence was observed in remembrance of silent keys. The following Board Members were in attendance: President Wolfe, Vice-President Traverson, Treasurer Ryan, and Board Members Gable, Robertson, and Snyder.

There were no additions or corrections to the January minutes as printed in the EVOX. Paul reported that treasury ended January with a balance of 1,735.78. A motion from Carl AA3IX and a second from Willie AB3BS accepted the Treasurer's report. The motion carried all in favor. President Wolfe thanked Paul for a great job and also advised the club that the Board audited the Treasury during the annual meeting in January.

Committee Reports:

Repeater – President Wolfe reported that he exchanged email with Jeff N3MFT to find out the status of the voting on 146.94. The work has not yet been started. The club was under the impression that the contracted service agency had to complete the task by the end of 2005 as was reported before, it seems the county has provided an extension to that timeline. Program – February 21 is our annual dinner meeting. This is at 1830 at the Whitehall Home style buffet. Information is available on the web site.

VE Team – President Wolfe reported that the VE team has been doing a great job and since it's inception in 2003 the team has been responsible for testing 53 people. President Wolfe also reserved the rooms from the Red Cross for the rest of the year.

Old Business-

- 1. President Wolfe reported that there are currently two potential field day sites, one in Allentown and one in the Orefield area.
- 2. President Wolfe reminded the members that both NIMS and EMCOMM Level I is the basic requirement for deployment with a RACES / ARES group in Lehigh County. Dick KA3MOU added that he spoke with Jeff N3MFT and if you don't have the proper training you will not be used in a key role. There was some discussion on this issue, and two members have not received their certificates from a NIMS course. They were advised to call LCCC and pursue their recognition.





New Business

- 1. The Board met on January 27. The Board discussed the future direction of the club and the importance of club member involvement, education and development. The Board also earmarked funds and established a Repeater Fund for the future replacement of 147.135.
- 2. Frank W3FTU discussed two fundraisers for the club's repeater fund. The first is running a ham fest table. Frank and Tom K3ARI will be attending the Cherry Hill Ham Fest and will be taking any item donated to the club to the ham fest for sale. Donated items will be sold for profit to the club. The second fundraiser is an on going collection of empty ink jet cartridges. The cartridges will be boxed up and sent to a recycling company and the club will get cash for their efforts.
- 3. President Wolfe described a third fundraiser for the club. A sandwich and hoagie sale will be offered for a delivery date of Wednesday April 19. The order forms will be handed out at the April club meeting with more detailed instructions. The club will get the sandwiches from the American Club of Coplay. The club should expect to make \$1.75 on each 9-inch hoagie and \$1.50 on each Kaiser roll sandwich. We will also run this sale in the fall.
- 4. Frank W3FTU will teach a CW course the same week as the VE test in March. The course will run each night from Monday to Friday and you will immediately take the CW test at the end of the course. President Wolfe added, not to wait for the FCC to drop their requirements, as the final outcome may not be what everyone is expecting.
- 5. The Board discussed being active in local events to become proficient in net operations and to provide community service. Mark AK3M has committed the club to provide support for a runner's road race on April 30. This event promises to be fun.

 New Members

Ike N3IK has applied for membership. Ike is a charter member of the club and the club welcomes him back to the fold after his absence.

Good of the order

President Wolfe reminded those present about repeater and phone patch etiquette and function. There has been a resurgence in phone patch use lately, and the President wanted the club members to remember that it is not secure communications and that you must ID after you are finished with your patch. That includes the hang up code.

Anyone interested in 10-meter code operation should tune to 28.175 between 1900 and 1930 on Wednesday and Thursday nights. Join in the fun.

Being no further business the motion to close was made by Larry KB3MHT and Larrie W2UL provided a second to the motion. All were in favor to close and the meeting was adjourned at 2045 hours EST.



First licensed in 1972 as WN5IGF, Harrison says he's interested in virtually all aspects of Amateur Radio, from HF DXing and contesting to VHF/UHF/microwave and moonbounce. He's an ARRL Life Member. His wife, daughter and son all are Amateur Radio licensees. He'll become the League's 14th president since its founding in 1914.






LVARC Member Makes QST


DID YOU KNOW ...

Imagine that you and your family are on a motor trip far from home. Suddenly, you are involved in a traffic accident. While you escape serious injury, your loved ones are seriously injured. They receive emergency treatment "on scene" by EMT's and paramedics. The ambulance driver asks if you have a preference as to which hospital you wish to have them transported. He states that there are two hospitals available, each is about five miles away, but in opposite directions.

The ambulance driver tells you that when Community Hospital is notified that they are about to receive several multiple-trauma patients, they page for "any available doctors and nurses" to respond to the emergency department. They believe that since doctors, nurses, and technicians are all licensed; having! an emergency team that works and trains together on a regular basis, really isn't necessary.

The driver also mentions that at University Hospital, they have a "trauma team" on stand-by that is composed of emergency physicians, trauma surgeons, trauma nurses, and technicians that work and train together on a regular basis. They all regularly take up-to-date continuing education courses and several have post graduate certification in various specialties. They know each other's abilities, strengths and weaknesses; and are familiar with their equipment and know how to use it even under adverse conditions. Which hospital would YOU choose?

Now let's take another scenario and apply it to emergency communications. Suppose that you are an emergency manager for a county emergency service agency. A major incident has occurred affecting your entire region or state. Commercial power, telephone and computers are all down. The hospital has a critical patient that urgently needs two units of B Neg." (Whole blood.) An emergency radio message must be sent to the blood center at the state capitol, 300 miles away to request two units of B Neg. to be sent by emergency airlift. The message must be sent "letter perfect". There is NO room for error. You have two choices:

- 1. You call a ham radio friend and ask him for help. He gets on a local repeater and says that all available hams are to report to the county EOC. Within minutes three licensed hams arrive. When you ask to send the emergency traffic, all you get is three blank stares. One of them starts calling for help on the repeater. Several hams answer and ask what is happening. But none of them know how to format and forward formal (message) traffic.
- 2. A trained and skilled EMCOMM operator is already at the EOC. She carries a HT, and has a VHF mobile transceiver in the parking lot. She tells you that a local emcomm net has already been activated and is in contact with a regional net. The operator quickly formats a formal message and within minutes transmits it to an Official Emergency Station for relay. Within 30 minutes the blood is aboard a State Police helicopter and it arrives in about 2 hours.
