

# Elimination of the CW Requirement and the **NOT AUTOMATIC** Upgrade Policy - de Mark (AK3M)

From the ARRL -Web Site - Jan. 24, 2007)

#### It's Official! Morse Code Requirement Ends

Friday, February 23 (Jan 24, 2007 [REVISED Jan 24, 2007 16:55 ET]) — Circle Friday, February 23, on your calendar. That's when the current 5 WPM Morse code requirement will officially disappear from the Amateur Radio Service Part 97 rules in accordance with the FCC's Report and Order (R&O) in the "Morse code proceeding," WT Docket 05-235. Beginning at 12:00 AM local time on February 23 (ie, after midnight Thursday), applicants for a General or Amateur Extra class Amateur Radio license no longer will have to demonstrate proficiency in Morse code. They'll just have to pass the applicable written examination.

CSCEs are only valid for examination credit for 365 days from date of issuance; applicants cannot use CSCEs older than that to upgrade. Volunteer Examiner Coordinators (VECs) will handle all upgrades through volunteer examiner teams.

# Anyone holding a valid CSCE may apply for an upgrade at a VE examination session.

As with any candidate who attends a test session, the candidate must present a photo ID, their current license and the CSCE document, pay the \$14 test session fee and fill out a NCVEC form 605 to have the upgrade paperwork processed. The upgrade is NOT automatic and may NOT be sent directly to the FCC or the VEC.




#### **ARRL Test Question Pool Schedule**

# New ARRL Department Gets Official Name



(Feb 1, 2007) -- As a result of an ARRL Headquarters reorganization announced in January, the Membership Services Department and Field and Educational Services combined into a single unit. The new department now has an official name: The Membership and Volunteer Programs Department (MVP). Dave Patton, NN1N, is the MVP manager. The reorganization also established a new position of Emergency Communications Manager within MVP and created a new Education Department (see pages 16-17).
