

"My Two Cents" ... de Mark (AK3M)



It Happened to Me! On Monday December 27, 2010, we all experienced the first Winter storm of the season. In Bethlehem (Northampton County), it wasn't the snow accumulation but the wind that caused me problems. I lost power for about four hours but was able to monitor VHF amateur, police and EMS traffic because of back up DC power. One of these included a battery from Cabela's which you can read about on page 10. The outage occurred early in the morning. was happy to know that I had battery back up for radios, cell phone and DC lights if needed. We keep talking about back up power but do you really have something to power your equipment in an emergency? I was glad to be tested and happy that I passed!

Thanks to Gary (W3GRD) who responded to the January, "My Two Cents," which invited readers to tell how amateur radio effected their life. Below, is his submission.

READER SUBMISSION

I was always fascinated by radio going back to the heyday of CB radios in the mid 70's. But after indulging in it for awhile became discouraged with it for the lack distance you could effectively communicate and the foul language and clowns that could be heard on the bands. I always kept a CB around especially for trips in which you could monitor for traffic conditions and to communicate between other vehicles in you're group.

Before getting my Ham ticket, I indulged in free banding on SSB and found some local groups that were nice to talk to. But just like CB, the jammers would move in and disrupt you, making communicating unpleasant. I then bought a scanner and would listen to the Ham frequencies and thought that I would give this a try. Well after almost two years now, I can honestly say I do enjoy the hobby and have never looked back. Most operators are pleasant to speak with and I enjoy talking to people all over the US and the world.

The only thing that I can say negatively is there are still those jammers that appear mostly on 75/80 meters, and I for the life of me, don't understand why someone would go to the expense of buying equipment and erect antennas only to spend there time harassing others. One of the first nets I jumped in on was with Fred and the Marconi net. The jammer gets on and harasses everyone. This has been going on for 2 years and the jammer is still out there. Not sure why this nutcase can't been found. Anyway, my only other complaint would be operators who tune up on the frequency they want to transmit on. This is incredibly annoying, especially when wearing headphones. Not sure, but I think, maybe they think they will not get lowest possible SWR if they don't tune up on that frequency.

Dr. Mike Martinez has already mailed me to let me know that he again wants the LVARC to provide communications support for the Lehigh Valley Road Runner's 2011 Half-marathon. While roaming around Cabela's the other week, I stumbled across this small size 8 Amp Hour rechargeable battery and charger. I purchased one and an extra battery. Using it as a test with my Yaesu FT817 (receive only with the back light on full) it lasted almost exactly 24 hours to the minute. Imagine the time you would get on an HT? I also found a great bag with side pockets that the battery fits in perfectly which leaves the middle part for radios, a small DC lamp cell phone, wires and any extras you may want to carry with you. It is an ideal "grab-it-and-go bag," that will keep you on the air for a week.

Below are pictures of my set up with the battery, bag and two harnesses I made. One is a female DC plug and the other is a 1.7mm plug which I can put directly into my VX7 or FT817. I also purchased an inexpensive meter at Harbor Freight and put alligator clips on the ends instead of the probes. This way I can monitor the voltage of the battery.




