




## The ARRL Extra Class License Manual Now Available on Kindl -- from the ARRL








## Musings from Field Day 2015 with the Lehigh Valley Amateur **Radio Club**

If you stopped and asked anyone for a one-word description of Field Day 2015, you might expect everyone to say "wet". Wet indeed! The rain that was scheduled to start Saturday morning around 11 am, decided to assist us with set up and came early, very early, around 7am. The rain came and never seemed to leave. It did come with varying degrees of intensity, along with 60 mph wind gusts and some prevailing winds that seemed to find even the most hidden dry spots.

Wet may come to everyone's mind as a good description of Field Day, and I could not argue. I would also like to offer some other words and descriptions:

Cooperation – Our members worked together to solve problems during set up, operations, and take down that would otherwise have been difficult to overcome.


Support – Our field day was supported by our members, and many other seen and unseen partners and family members. We were greatly supported by family members that made sure we had warm, tasty food and snacks. Support came from outside agencies like South Whitehall Township for being our host year after year and providing an outstanding Field Day location.

Partnership – Lehigh County Emergency Management Agency has always taken a huge role in our event and Director Scott Lindenmuth paid a person visit to see our club in action and received a personal demonstration on wireless data transmission of ICS forms using FL Digi. Lehigh County has always been an active partner in our Field Day events, but this year an unfortunate stumbling block actually enabled us to form additional partnerships. Early on Thursday before Field Day, the coordinator received news that the Lehigh County Command Post, which has been used for Field Day for over 5 years, was out of service and mechanically could not be utilized. Through additional contacts we were offered the use of an inflatable tent from Eastern PA EMS Council. The tent served as both an operating position but as shelter, warmth, and a place to get dry and enjoy fellowship, and another partnership was strengthened.

Perseverance - Despite poor weather, the antennas were setup and taken down under controlled conditions. The VE Team was able to test new candidates, and the radios had operators stationed at the ready. Even those that departed for dryer and warmer conditions at home returned for more!

Achievement - We set our goals as a club to operate Field Day. We achieved our goals through the cooperation of members, the support of families and allied agencies, the partnerships with our served organizations, and by persevering through lots of liquid sunshine. There were also those that came to their very first Field Day and achieved their first license.

When you reflect on Field Day 2015, think not of the weather, but think of those that viewed our efforts without bias, and be proud of our collective accomplishment through adversity. After all, isn't Field Day supposed to test our mettle?

## **Mickey is NOT** A Ham!

We all know and love Mickey Mouse. Mickey and his friends have appealed to all of us as children and adults. The Disney company has provided us with many hours of entertainment from their parks as well as their movies/cartoons and their their cruise line.

In the beginning of July, 2015, we took our children and grandson on the Disney Dream. It was a wonderful trip as well as a marvelous ship. One of the ports of call on the trip was Freeport, in the Bahamas (C6). "Out of the country?" "An opportunity to use ham radio out of the U.S.?" I called a travel agent and asked if I could use my VX-7 on the cruise. The law states that with permission of the master (captain), that is allowed. Well, Disney, has its own idea about amateurs being maritime mobile. The result of my call revealed that no ham radios are allowed on the Disney ships. That doesn't mean you cannot *take* your VHF radio but it DOES mean you cannot *operate* while on board the ship. VHF amateur radio frequencies are just below the marine frequencies on the RF spectrum so I can understand their caution but it also may be that they do not understand ham radio and it may be easier just to have a, "No ham radio," policy. No matter what their reason, if you travel aboard one of Disney's four cruise ships, leave you HT at home, or use it as a scanner only unless you get off the ship at a port.
